

Insight® GynoCart® Limited Warranty

This warranty is provided by Marketlab, hereinafter referred to as the "Manufacturer," to the original purchaser of the product. This warranty is applicable to the Insight GynoCart, hereinafter referred to as the "Product."

Coverage:

The Manufacturer warrants that the Product will be free from defects in materials and workmanship under normal use and conditions during the following warranty period(s):

- 1. Cart Warranty:
 - a. The body and structural components of the cart will be free from defects in materials and workmanship for a period of two (2) years from the date of purchase
- 2. LED Light Warranty:
 - a. The LED light will be free from defects in materials and workmanship for a period of three (3) years from the date of purchase
- 3. Stool Warranty:
 - a. The stool will be free from defects in materials and workmanship for a period of twelve (12) years from the date of purchase
- 4. Exam Pad Warranty:
 - a. The exam pad will be free from manufacturing defects for a period of sixty (60) days from the date of purchase
- 5. Caster Warranty:
 - a. The casters will have a 1-year warranty from the date of purchase. If the casters are modified or used in a way in which they were not designed, the warranty will be void.

Warranty Claims:

If the Product exhibits defects covered by this warranty, the original purchaser should promptly contact the Manufacturer. The Manufacturer may, at its discretion, repair or replace the defective product or its components.

Exclusions:

This warranty does not cover damage or defects resulting from:

- 1. Normal wear and tear
- 2. Misuse, abuse, or neglect
- 3. Unauthorized repairs or modifications
- 4. Accidents, acts of nature, or any other external causes
- 5. Use of the product in a manner contrary to the instructions provided by the Manufacturer

Limitations:

The liability of the Manufacturer under this warranty is limited to the repair or replacement of the defective product or its components. In no event shall the Manufacturer be liable for any incidental, consequential, or indirect damages.

How to Obtain Service:

For claims under this warranty, the original purchaser must:

- 3. Provide original purchase order number and Product lot or serial number

Disclaimer:

This warranty is the sole and exclusive warranty provided by the Manufacturer, and no other warranties, whether expressed or implied, are made. The Manufacturer disclaims all implied warranties, including without limitation, the implied warranties of merchantability and fitness for a particular purpose.
